You may know where you are at, but what about family members or those visiting you at the lake.

### **Students can receive a letter from NCSU acknowledging volunteer hours!**

Fenced in areas, called exclosures or cages, are constructed to protect & develop colonies of native vegetation. The cages protect the newly planted native vegetation from being eaten by herbivores, such as turtles and grass carp.

Native vegetation provides habitat for fish and waterfowl, reduces shoreline erosion, replaces invasive plants, anchors sediment and improves water quality.

## ***More from Lake Environment Committee***

In addition to planning for our work on Habitat Enhancement, the Lake Environment Committee is working on Water Quality by:

### **Determining the best locations to take water samples for E.coli testing.**

In the past we have made these test kits available to members for testing their shoreline. With a limited number of kits we will focus our efforts on creeks feeding the lake. Committee members will pull samples and conduct tests on these “feeder” streams and creeks once water temperatures warm above 75 degrees F.

If you are aware of a potential E.coli issue, i.e. failing septic system, concentration of geese or other animals, contact us for test kits. The Water Quality experts tell us that frequent sampling is required for valid results.

### **Raising awareness on Over Occupancy of Rentals and the related potential Health Issue.**

We will be discussing this issue with the Warren County Environmental Health Department at our May meeting. We continue to see advertisement for residential rentals offering significant number of beds well over the number of bedrooms. Potential for septic system failure increases with resulting impacts to water quality. The Lake Environment Committee wants to raise awareness and determine how the LGA can help prevent negative water quality impacts.

### **Monitoring Erosion and Sediment Control Practices.**

The Committee is notifying the proper authorities where we have seen insufficient erosion and sediment control measures. Building sites frequently involve land disturbance in close proximity to the lake. These sites must be stabilized with plantings and/or silt screens to prevent erosion and sedimentation. Sediment is a form of pollution which negatively impacts water quality.

## ***Lake Gaston water level change -***

### ***Fish Spawning season March 1 thru June 15***

Effective March 1 Dominion Energy is operating under fish spawning operations. This means that Lake Gaston can be raised an extra foot (199-201 feet) to provide storage in support of spawning flows as necessary. Dominion Energy has stated that they don't expect to raise the water level much more than a couple inches over 200 feet.

Nevertheless, experience has taught us to be prepared. We know that once we get above 200 feet we begin to encroach on many of our docks. You are reminded to make sure that any items that are on your docks are securely tied down including canoes and paddle boats. Items sitting on the floor of boat house sheds should be moved up to prevent the possibility of water damage. Boats in docks should be securely tied and boats in lifts should be raised and tied.

## *Buoys placed in Lake Gaston need state & federal approval*

Dominion Energy as well as the Virginia Department of Game & Inland Fisheries and North Carolina Wildlife Resources Commission have received complaints concerning buoys being placed in the lake to deter boats near boat docks.

Both Virginia Department of Game & Inland Fisheries and North Carolina Wildlife Resources Commission, as well as Dominion, do not allow buoys to be placed in the lake without state and federal approval. Any buoys placed in the lake will be considered an obstruction to navigation and will be required to be removed.

## *Free Vessel Safety Check*

Flotilla 93 will perform a free Vessel Safety Check on your boat at your home. The boat can be in the boatlift or on a trailer and does not need to be running. They will also provide a Vessel Examiner at your Home Owners Association Meeting to inspect boats after your business meeting. Call John Dyckman at (252) 537-9877.

## Swimming shouldn't tingle!

The boating and swimming season is here.

Electrocutions in the 1980s were a major force to the creation of The Lake Gaston Water Safety Council.

If you are swimming and feel a tingle, reverse direction and go back the way you came from. If you jump off of the dock and get shocked, get away from the boathouse.

If you are in the water and receive a shock by touching a metal ladder, a metal lift cradle, or cable, don't assume that it was static and touch it again to check it. In both cases, once you are safe, secure the area to keep anyone else from getting in the water and call an electrician.

### Items to remember throughout the season are...

Alcohol is the number one reason for boating accidents.

Almost all fatalities on the water last year were NOT wearing a life jacket.

Dehydration is a serious concern.

Please drink water all day long.

Use shade or sunscreen to protect yourself from a sunburn.

Know the symptoms and treatment of heat exhaustion and heat stroke.

Finally, allow more than enough time for each activity so that you aren't rushed and look out for everyone around you.

America's Boating Course is an eight-hour course covering the basics of boating and is appropriate for youth as well as the adult boater. Successful completion of this course satisfies the education requirement to operate a boat in ANY STATE and for youth to operate a PWC in both Virginia and North Carolina.

**Virginia Law** : All Virginia boaters in the waters must have proof of taking a Boating Course.

**North Carolina Law**: Requires that all PWC and Motor Boat Operators born after 1 Jan 1988 will have proof of completing a Boating Course, if they are operating a vessel with a 10 HP engine or greater.

In **North Carolina**, WRC enforcement officers are the point of contact.
