Fall is Upon Us!

For the first time in several years the weather was great, the Lake Gaston Festival enjoyed terrific weather and big crowds. Our LGA booth featured a popular hands-on display of aquatic plants and photo exhibit of local snakes, all of which can be found in and around Lake Gaston. So many people, young and grown up, stopped by to talk about our exhibits and what we do. It was terrific to meet and talk with so many interesting folks from near and afar.

We are now in the middle of our Fall Lake Survey of aquatic vegetation around the whole 350+ miles of our shoreline. This survey is done by volunteers – us – to help NC State University with the management of the plant life in our lake. Plants are an important part of the lake ecosystem, we have both good and bad, or invasive, plants.

Many people don't realize it but, our lake community is at the forefront of determining just how to combat these invasive plants. Over the next few months, NCSU will be analyzing the data that has been collected and formulating strategies for managing the aquatic world below us.

Also, as the summer crowds disappear, it is all the more important to support your local businesses. If we don't support them, they may not be here when you really need them. At the end of every issue of the LGA Bulletin, there is a listing of all our business members. You can also find them by going to the LGA website. That list is a good place to start looking for a local source.

Fall Lake Vegetation Survey now underway

Volunteers are needed to float the shoreline and conduct our annual vegetation survey.

This is a great chance to slow down a bit and see up close the shoreline that you usually pass by while skiing, pulling a tube or just sight-seeing.

Information gathered by volunteers about what types of vegetation is growing and where along Lake Gaston's shoreline is vital in determining how best to manage the vegetation. It helps us identify problem areas, how the native plants are doing and what trends are seen over time.

Jessica Bauman, Extension Associate for Lake Gaston with NC State University's Aquatic Plant Management Program, is working closely with the LGA Lake Environment Committee to coordinate the survey. We held three short training sessions at the end of August to acquaint volunteers with the process.

While we continue to make improvements, the process remains much the same. All that's needed is your time, the means to float along the shoreline and a willingness to get "hands on" with the plants along the Lake Gaston shoreline. If you would like, we can team you up with some more experienced folks.

So come out and enjoy the beginning of cooler days on the water .If you are interested in joining the volunteer efforts during the fall vegetation survey, please email aquaticplants@ncsu.edu.

Great tips to stay safe and sound

We just had our first scramble to buy the last loaf of bread and bottle of water with the hurricane Dorian warning. Another severe event missed us here, but it's important to remember there is no absolute predictor of where a weather event will mature or do its worst. Preparedness is a necessary part of any impending storm.

Hurricane Floyd was the last hurricane delivering significant damage locally, leaving evidence for a number of years. Predictions and tracking are far better now, but we need to accept that predictions rapidly change and Mother Nature has her own will in setting course which can deliver a punch or amble by with hardly a rumble. Please know warnings are the best officials can do, and you must be willing to protect your family and get out of harm's way, even if the hint is the storm will pass without consequence.

There are a number of useful links on the Safety Committee page of the LGA website to help you prepare for destructive weather or just to get ready for winter. Take a moment to check out the one from FEMA <https://www.ready.gov/make-a-plan>. Make adverse weather and disaster planning a family activity, have children and grandchildren embrace the potential reality and provide suggestions. We are currently reviewing and updating the information on the webpage for safety and will be more proactive with renewed flexibility in maintaining the website. As a reminder, the Safety page also has information to register for the emergency notification network in each of the lake counties.

The September LGA monthly meeting featured the Sheriffs of our lake counties providing a number of tips for resident security. Homeowner Associations and homeowners are strongly encouraged to make an investment in low light, motion activated cameras, both in homes and at entryways of the subdivision, so faces, vehicle make and model, and license numbers are captured. Some of these systems can even be monitored on smart phones. Each year the Sheriffs remind us the perpetrator seeks out the easy victim, making loud, irritating alarms quite useful in driving the uninvited away. While silent alarms can initiate a 911 response, the silence does not deter the thief and provides time for them to cart off small valuables, cause damage, or worse injury.

We are extremely fortunate here to have so many friends and neighbors who are employed by law enforcement, and emergency medical services, or who volunteer with the fire departments and rescue squads. It's so important to take a moment and tell them you appreciate what they do. Most volunteer organizations can use help with administrative tasks if you are not able to physically help with fire or rescue services. You can always stop by a Sheriff's office, Volunteer Fire Department or Rescue Squad to say thank you and leave a case of water, soft drinks, some subs or a pizza or two. You'll feel good and they really appreciate the effort. Besides you might see them again when you really need to and then you will be proud that you said thanks before you needed anything.

Please take preparedness in protecting your family seriously. Buy a case of water and a 5 gallon container before the next storm. As we come into the season, get a bag of salt for the first ice/sleet event and get that chimney cleaned to avoid deadly fires. Change batteries in the smoke and carbon monoxide sensors and replace the smoke detectors that have stopped working altogether. Secure boat, deck and yard items, and take action to avoid frozen pipes.

Our Toy Drive will conclude at the December 4 LGA monthly meeting at the Lake Gaston Baptist Church where we will present Jodie Dowhan, John 3:16 Board Chair with the toys, books, games, etc., etc. Toy collection boxes will be available at the meeting between 9:30 a.m. and noon. The Center asks that all gifts be new and unwrapped. They do not distribute any toy weapons of any kind.

Gender-neutral gifts are always good: puzzles (under 500 pieces), books, board games, coloring books, baby's toys, etc. They have had children registered from 1 month old to 16 years old. Every child gets a book, so appropriate books for different age levels (books boys may enjoy are often hardest to find) will be appreciated. Balls, dolls (ethnically diverse), art supplies, craft/model kits, small handheld electronic games, toy cars and trucks, watches or inexpensive jewelry for older children, etc. also are typical of the types of gifts given in the past.

Social Butterflies

Social Butterflies would need to come to The John 3:16 Center for orientation. Interviews will begin November 5th to as late as November 20th, but will end once we have 175 children served. Volunteers would need to sign up for at least a two hour period one of these days.

Shoppers

In Store - Shopping will begin once the interviews are complete and have been vetted. Everything will need to be purchased prior to November 6th. Shoppers would assist Shannon in buying mostly clothing and shoes for specific children.

Personal Shoppers - Assist parents in choosing the presents for their children. This added step lets us get to know the families even more as a volunteer "shops" with them in our store set up in the Littleton UMC Fellowship Hall from December 12-19th. Volunteers would need to sign up for at least a two-hour period one of these days.

Wrappers

Wrappers will assist the parents in wrapping their children's gifts after their shopping appointments, December 12-19th between 9am and 5pm until all of the presents have been wrapped. All supplies including tape, paper, scissors, boxes, etc. will be provided. We will be wrapping in the Littleton UMC Fellowship Hall.

Party People

The Christmas parties will be held December 21st at 11am, 12pm, and 1pm at The Center. Volunteers would need to arrive at 10am. Of course, volunteers are welcome to help later in the day if they cannot make it at 10am. Volunteers help in many areas including serving food, as Santa's elves, helping with parking and taking gifts to the car.

US Coast Guard Auxiliary Flotilla 93 - 2019 training dates

October 26

America's Boating Safety Course is an eight hour course covering the basics of boating and is appropriate for youth as well as the adult boater. Successful completion of this course satisfies the education requirement for youth to operate a PWC in both Virginia and North Carolina.

Remember: **Virginia now has a law** that all boaters in the waters of Virginia will have proof of taking a Boating Course. All Motor Boat Operators operating a vessel with a 10 HP engine or greater, must meet these requirements. All PWC Operators regardless of age must have proof of taking a Boating Course.

North Carolina Law effective January 1, 2014 requires that all PWC and Motor Boat Operators who were born after 1 Jan 1988 will have proof of taking a Boating Course, if they are operating a vessel with a 10 HP engine or greater.

Clarification: Boaters on Lake Gaston need to be in compliance with their state of residence for Boater Education Certification. This is true whether the boater is a resident of North Carolina, Virginia, or any other state as recognized by both states' enforcement officers.

The fee for the course is \$30.00, **Preregistration and prepayment are required.** Courses are now taught at the Long Bridge VFD, 1678 Eaton Ferry Rd., Littleton, NC 27850. All classes are on Saturday from 8:30am to 5:00pm, with the exam given at the end of class.

Please bring your lunch. Bottled water and sodas can be purchased for 50 cents. It is a busy day - but rewarding. Remember – **Preregistration and Prepayment are required.**

If you notice a mile marker buoy that is damaged, light is out, is missing from its mooring, has washed up on the shore, etc., please contact the LGA at info@lakegastonassoc.com or (252) 586-6577 or 1-888-586-6577 and we will report it to Dominion. Similarly, if you notice a danger or no wake buoy damaged, missing, etc. please contact us as above and we will report it to the NC Wildlife Resource Commission or VA Department of Game and Inland Fisheries.


